Knowledge valorisation is about transforming scientific knowledge into practical solutions that benefit everyone. Enhancing it is crucial for addressing challenges such as climate change, digital transformation, socio-economic issues, security, and defence.

The Italian Ministry of University and Research (MUR) is involved in many projects finalised to deliver impactful policy reforms aimed at empowering Italy's state-owned universities to promote knowledge valorisation by focusing on developing and improving relevant networks, infrastructure, and services.

This agenda details the program of a **one-day event in Italy on knowledge valorisation**, designed to align **EU and national policies** by fostering an open exchange between
stakeholders. The event provides a platform for mutual
learning where representatives from Italy and the
European Union can share insights, best practices, and
strategies to enhance knowledge valorisation across

The Code of practice on industry-academia co-creation for knowledge valorization provides guidance and relevant tools for research and innovation actors to engage in co-creation in view of faster market uptake of innovative solutions. It introduces a new strategic approach for industry and academia to actively seek for common interests and jointly produce and valorise knowledge. Participants to the workshop will have the chance to listen from the European Commission about the recommendations in the Code of practice on industry-academia co-creation for knowledge valorization and to share their views and best practices.

Participants at the table will have the chance to describe the results of the EU-funded TSI project "ITA.CON", including its Final Report, presented last January, alongside the key initiatives of the EU in the area, such as the recommendations adopted by the Council of the European Union (Council Recommendation (EU) 2022/2415 of 2 December 2022 on the guiding principles for knowledge valorisation). It is a crucial document in shaping the strategy for reforms and changes that the Ministry is implementing. The ITA.CON report also serves as an invaluable working tool for Italian universities. Through the Conference of Italian University Rectors (CRUI), universities have initiated their own working group dedicated to Knowledge Enhancement and the Third Mission.

This session will present key initiatives developed within NETVAL - the Italian Network for Knowledge Valorisation and will showcase concrete examples of knowledge valorisation from across Italy.
